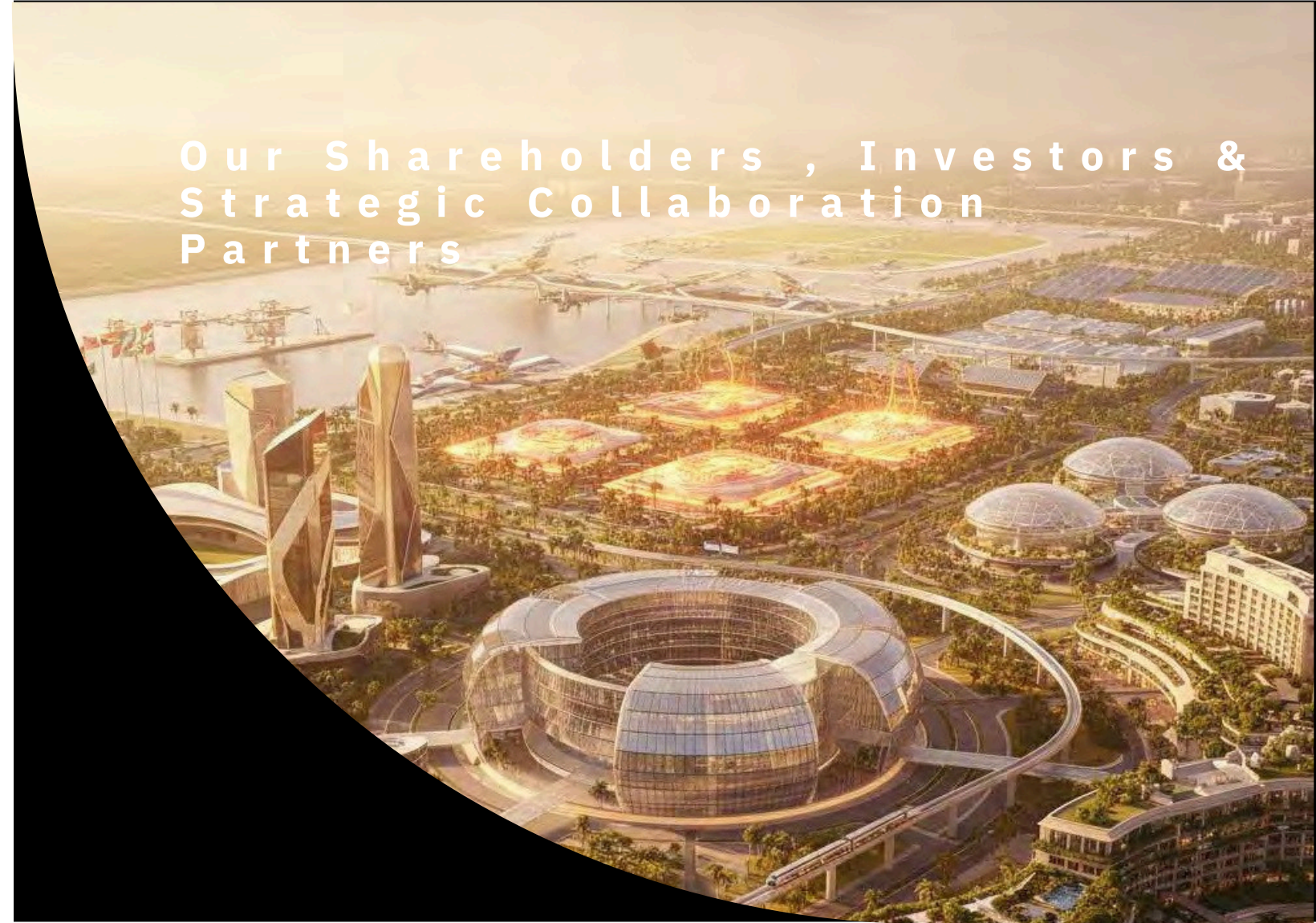

HDH Investments is a partnership between HDH International, Saudi Bin Laden Group (SBG), PIF / AL ISTEDAMAH HOLDING (Saudi Arabia Sovereign Wealth Fund – Saudi Arabia Ministry of Finance), and Inventure Group.

Al Istedamah Holding is a major Saudi Sovereign Wealth Fund. It is wholly owned by the Government of Saudi Arabia (Ministry of Finance) and was established as a holding company to oversee and manage a portfolio of assets and investments in various industries, including real estate development, finance, technology, media, healthcare, insurance, energy, industrial, and infrastructure. Al Istedamah Holding is also known for its significant stake in MBC Group, the Middle East's largest broadcaster, of which a 54% majority stake is held by Saudi Arabia's Public Investment Fund (PIF). As of January 2026, Al Istedamah Holding acquired a dominant majority stake of 86.38% in the Saudi Binladin Group (SBG), which stabilized the construction giant with a \$15 billion (SAR 56 billion) cash injection to ensure the ongoing development and continuity in delivering major projects for Saudi Vision 2030 and internationally.

The primary objective is to drive growth and profitability by acquiring, managing, and optimizing the performance of its subsidiary companies and investments, operating as an investment vehicle involved in various local and international ventures, to diversify the economy, supporting the growth of the region's diversified businesses and projects across various sectors.

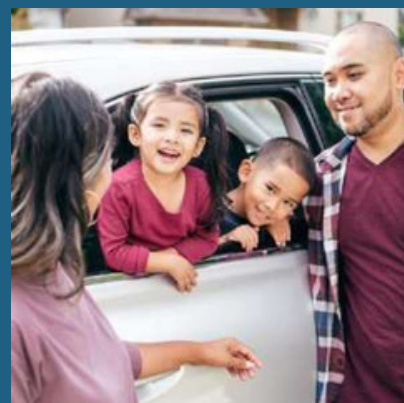

- **Traditional Insurance:** Covers unforeseen events (e.g., accidents). **Expects losses.**
- **Surety Bonds:** Guarantees the performance of a contract. **Expects no losses.**
- **Relationship:** Surety involves three parties (obligee, principal, surety), unlike two in insurance.
